PURPOSE

Our uniform seeks to contribute to enhance the profile and identity of the school and its students within the wider community. It aims to strengthen the spirit of the school community. The philosophy underpinning our uniform policy represents our inclusive culture which is one of belonging and embracing diversity and includes our set of values conveyed in our philosophical statement "The Glen Eira 5".

This policy aims to meet the following criteria for a school uniform:

- Practical
- Reasonably priced
- Comfortable
- Inclusive
- Smart and casual

GLEN EIRA COLLEGE UNIFORM STANDARDS

The official school uniform is to be worn in its entirety as described in this policy. Any student is permitted to wear any of the approved uniform at any time of the year (unless otherwise stated in this policy e.g. PE uniform).

The school uniform must be worn:

- Each school day from the time the student leaves home until he/she returns home
- To and from venues of official sporting fixtures and other events where students are representing the school
- When attending official school functions including excursions and incursions

A note from a parent / guardian is always required if students are not in correct uniform. A pro-forma note is included in the planner. Sanctions apply for non-compliance.

In cases of economic hardship, parents or guardians should contact the Student Wellbeing Leader for assistance. The school encourages SunSmart practices (e.g. wearing a school sun hat for PE in term 1 and 4) as outlined in the school's **Sun Protection Policy**.

GLEN EIRA COLLEGE UNIFORM

The following are the approved uniform items for all Glen Eira College students:

| | Appropriate length - not shorter than 5cm above the knee. |
| White shirt | White short or long-sleeved straight cut. |

| Shorts | College grey tailored. |
| | Appropriate length - not shorter than 5cm above the knee. |
| School skirt | Glen Eira College design only. |

| School jumper | Glen Eira College design only. |
| | For students with allergies, a cotton College jumper is available. |
| School blazer (optional) | Glen Eira College design only. |
| | May be worn with or without jumper. |
| School jacket (optional) | Glen Eira College design only. |
| | May be worn with or without jumper. |
| | May be worn as part of the PE uniform. |
| | Year 12 students have an alternative jacket. |
| School puffer jacket (optional) | Glen Eira College design only. May be worn with or without jumper. |
| Waterproof jacket (optional) | Glen Eira College design only. |
| Socks | Plain black socks. Socks must cover the ankles. |
| Tights | Opaque black (60 – 80 denier) and worn only with skirt. |
| Shoes | Black leather lace up school shoes (no T-bars allowed). |
| | Gym shoes/runners are not to be worn except for PE, sport and lunchtime sporting |
| | activities. |
| | Year 10-12 students must only wear runner/gym shoes during timetabled PE classes, |
| | recess, lunch and sporting events and must change into school shoes before class. |
| | Thongs, sandals, and boots are not acceptable footwear. |

STUDENT APPEARANCE

Hair

- Hair styles should not be extreme. This relates to cut, colouring and length.
- Hair is to be worn in a neat and tidy manner. Hair must be tied up clearly off the collar, face and ears for
 practical classes including science, PE and food technology. Only red, black or grey hair ribbons/head bands
 are permitted.
- If hair is coloured it must be a natural hue. Hair may be coloured in non-natural colours for House Athletics or Swimming or school productions only with temporary colour (24 hours).
- Facial hair is not permitted, and students are expected to be clean shaven at all times.

Jewellery and makeup

The only jewellery permitted is:

- Two pairs of earrings (surgical sleepers or studs) in the ears only. These must be plain gold or silver (no colours). Maximum diameter of stud is 3mm. Maximum diameter of sleeper is 10mm.
- One nose piercing (stud only). No other piercings are permitted.
- Watch.
- Any other jewellery is not to be visible.

Make-up should be natural in appearance. Natural coloured foundation with SPF is permissible. Fake eyelashes are not permitted. Nails must be of a reasonable length to participate in the curriculum safely.

Other

- Tattoos must be covered at all times.
- School bags should preferably be the approved Glen Eira College bag.
- Head scarves should be plain black or white only.
- Non-school hats, including beanies, are not to be worn.

EXEMPTIONS FROM DRESS CODE

Legal requirements necessitate that exemption from the Glen Eira College Uniform Code can be provided where an aspect of the code:

- Offends religious beliefs.
- Prevents compliance with an ethnic or cultural belief.
- Prevents students with disabilities from being able to participate in school
- Affects a health condition

Applications must be made to the Principal and must be accompanied with the necessary verification documentation i.e. medical certificate, letter from religious leader, etc.
